2. Interested parties may send their bids in sealed cover latest by **29-04-2023** up till 10:00 am which will be opened on the same day at 11.00 am. The bidders or their authorized representatives may attend the meeting, if they wish to be present.
3. 2% of total bid amount as Earnest Money/security deposit should be attached with the tenders, in the shape of the Call Deposit, in favor of Senior Civil Judge, North Waziristan@ Rs. 49,700/- Tenders with Cross Cheque/ Banker's Cheque, demand draft and without call deposit shall not be entertained. The Earnest Money of the unsuccessful bidders, however, shall be returned after approval/finalization of the tender.
4. **The bid security/earnest money may be forfeited:**
 - a) If a bidder withdraws his bid during the period of bid validity specified by the bidder on the bid.
 - b) In the case of a successful bidder, if the bidder fails to sign the contract or fails to supply the equipment within the specified delivery time period.
 - c) If the bidder fails to supply the equipment within the delivery time period.
5. **The procuring entity shall disqualify a supplier or contractor if it finds, at any time;**
 - a. That the information submitted by him concerning his qualification as supplier or contractor was false and materially inaccurate or incomplete.
 - b. That old register firm fails to submit the last 03 years and newly register firm fails to submit last one year Sales & Income Tax returns along with audit report.
 - c. That if he fails to provide KPPRA registration.
6. Price quoted must be in Pak Rupees and must include all applicable taxes. If not specifically mentioned in the tender/quotation, it will be presumed that the price include all the Government Taxes.
7. Supplier shall be entirely responsible for all taxes, duties, license fees etc incurred until delivery of the contracted goods to the Procuring Agency.

8. Firms shall give 01 year warranty with parts and After Sale Services for the equipment they offer.
9. Installation of equipment shall be the responsibility of successful bidder.
10. Contract shall be awarded to that supplier who fulfills the above mentioned specifications as per the satisfaction of procuring entity.
11. Successful bidders shall be required to supply the said items within 15 days after the issuance of supply order by the competent authority. Failure in supply of items within stipulated period shall entail forfeiture of earnest money.
12. In case, even if after delivery/installation within three month, the technical committee found the items/equipment defective, low quality, not working properly, or any other fault, the competent authority has the right to return the defective items/equipment for replacement or may award the bid to the next lower bidder after cancellation of this supply order.
13. The procuring entity reserves the right to reject any or all tenders with cogent reasons.
14. Incomplete, ambiguous, and conditional bids will not be entertained.
15. Bids can be submitted by post or delivered directly in the office of Undersigned.
16. The purchase will be made in accordance with KPPRA Rules 2014.
17. Successful bidder shall deposit a performance guarantee 8% of the total supply cost.
18. Bid should be valid till 30th June 2023. The firm/bidder would be bound to supply the tendered equipment on the rates mentioned in the bid. Any fluctuation in rate would not be entertained by the procuring entity.
